Being a private person I had refrained from publicly announcing my personal health concerns. With the recurrence and surgery in December 2007, a third recurrence and surgery in July 2008 and six weeks of immunotherapy this past Fall, I have accepted this not as a stigma but a fact of life that must be dealt with.

# SPECIAL CALLED EXECUTIVE BOARD MEETING REPORT

On January 3, 2009 at the Baymont Hotel in Cookeville TN. a special called TARS Executive Board meeting was held. The purpose of this meeting was in reference to the action taken on December 10, 2008, by Executive Director Steve Carden in requesting and accepting the voluntary resignation of State Training Coordinator Rusty Williams as a paid employee of TARS. In the best interest of TARS, a compromise was met and agreed upon by Executive Director Steve Carden and Rusty Williams. This compromise is stated as follows: Rusty Williams would rescind his voluntary resignation as State Training Coordinator and Executive Director Steve Carden would rescind his actions in asking for the resignation. This action would reinstate Rusty as the paid State Training Coordinator with some new guidelines.

A committee was appointed by me, which consists of the training committee who include Kenny Blaker, Kevin 'Bucky' Ayers, Jim Houston, Cecil Nunley, and John Weaver. Also appointed were Steve Carden, Rusty Williams, Sam Oldham and Tim Bell.

This committee was charged to oversee the progress of Rusty Williams. State Vice President Kenny Blaker set a committee meeting to be held at the Newport Rescue Squad on February 7, 2009.

This meeting is to set realistic goals and objectives

for Rusty to obtain by October 2009. These goals will be agreed on by the committee and an on-going evaluation process will be implemented.

The committee will report to the Executive Board at the Double Tree Hotel in Murfreesboro on March 28, 2009. The Executive Board will in turn make a report to the Board of Directors. The committee will once again report to the Executive Board at the Double Tree Hotel in Murfreesboro on July 10, 2009. The Executive Board will again make a report to the Board of Directors.

The final meeting of this committee will be at the Music Road Hotel & Convention Center in Pigeon Forge October 1-3, 2009. This meeting will take place during the 54th annual convention. The Executive Board will make their final report to the Board of Directors. Also, at this point a final three year review of the paid State Training Coordinators pilot program will be completed determining its success or failure.

I would like to take this opportunity to thank all of you for taking an interest in your local Organizations, TARS and the Rescue College. We can't have one without the others and in order to stay strong we need to support each other moving toward a common goal.

Simultaneously, during the banner year of 2008 I was faced with as difficult decision as I have had to make as Executive Director of this Organization. (Reference President's Special Called Executive Board Meeting Report). The Executive Board did not support me in this decision. I hold no hard feelings toward anyone and accept their determination with respect, and as an attempt to mitigate a difficult issue under the circumstances. Nonetheless, I stand by my decision and its basis, contained in a full evaluation on record with the State Secretary, as being in the best interest of this Organization.

Subsequently I have decided to accelerate the search and confirmation of this Organization's next Director and intend to complete my tenure at the end of the fiscal year June 30, 2009. The Executive Director needs the full confidence of the Executive Committee, which the position answers to. To delay this transition any longer than necessary would not serve the interests of the Association.

Ironically in the last week I have been informed of another recurrence of my cancer which is to require surgery at the end of January. This simply confirms my decision to proceed with the process of seeking a replacement. I am a person of faith and believe everything in life has a purpose and reason. I choose

to believe this not to be an obstacle, but an opportunity to focus 100% on my personal battle. Additionally, this organization deserves someone that can give it their full attention and commitment.

I may not see many of you during the February meetings, depending on my recovery and required treatment, however I hope to be active as possible and working through the hiring and training period for the next director.

I have been very blessed to have had the opportunity to be involved in this Organization for 35 years. The experiences and friendships made have been an important part of my life. I deeply appreciate the cooperation and support I have been afforded and trust you will extend the same support to my successor. My challenge to you is to continue your dedication and service to your local unit and your Association. While some obstacles may appear, may you treat them as opportunities, for when one door closes, another one often opens if you look for it.

# ADVANCED EXTRICATION

<u>Course Description</u>: The Advanced Extrication Course gives more detailed use of tools. It also has more one-on-one instruction. The theory of Extrication is more complete. This is taught on a Regional basis by College Instuctors.

Pre-requisites: Basic Extrication

Course Hours: 20/ Min Enrollment: 20 Max: 40

NOTE: Participants will be required to furnish and wear full protective gear for all field exercises. (Extrication coveralls are acceptable but most do not meet NFPA standards.)

# FARM RESCUE

<u>Course Description</u>: The Farm Rescue Class is designed to introduce the student to situations and hazards related to Farm Related Accidents. Identifying hazards such as fertilizers, pesticides, and silos, as well as stabilization of tractor overturns and equipment disassembly are some of the subjects covered. This class is a mix of classroom and field exercises and is taught on a regional basis.

Pre-requisites: Basic Extrication Course Hrs: 20

Min Enrollment: 20 Max: 40

NOTE: Participants will be required to furnish and wear helmet,

gloves, eve protection, and boots.

#### TRENCH RESCUE

<u>Course Description</u>: The Trench Rescue Course is designed to impart knowledge and develop skills in order to properly shore trenches and to affect a cave-in rescue quickly with a minimum of danger to those involved. It will teach the student how to utilize equipment and resources already at their disposal as well as recognize the resources in the community that can be readily used in Trench Rescue. This class is taught on a Regional basis.

Course Hours: 20/Min Enrollment: 20 Max: 40

NOTE: Participants will be required to furnish and wear helmet, gloves, eye protection, and boots. and protection harness.

## **INSTRUCTOR I**

(Extrication Series or EVOC/VFK/BBP Series)

Course Description: The Instructor I course is designed to enable a student to teach a class from a prepared lesson plan. It prepares you to instruct the TARS basic squad level courses which include Vehicle Extrication, Emergency Driving (EVOC/VFK) and Blood borne Pathogens. Separate modules are offered and if attended with in 1 year of the initial Instructor class the additional discipline class fee is offered at half price. Concepts of learning, communication skills, instructor's roles and responsibilities, teaching techniques, and the use of instructional materials are also subject areas included. This class is taught on a regional basis.

Course Hours: 24/Min Enrollment: 20 Max: 40

Pre-requisites: Must have a high school diploma or GED certificate and have been a member of an emergency organization

for three years. Students should have been certified in squad level courses within the last two years and have a First Responder medical level training (or equivalent) rating. It is also preferred that a candidate have attended either the College Advanced Extrication or School Bus Rescue course for Extrication Instructor consideration.

Reference Material: IFSTA Fire Service Instructor TARS Instructor EVR Manual, Blood borne Pathogen Instructor Guide, EVOC Trainers Manual, VKF Package

NOTE: The student may be required to give one five minute presentation on a (may be non-rescue related) subject of their choice. Any visual aids must be provided by the student. Another presentation may be required on an assigned topic. In the Extrication Series each student must provide and wear full protective gear for field exercises. Rescue tools are provided.

# SWIFT WATER RESCUE I

<u>Course Description</u>: The Swift Water Rescue I class will teach swift water dynamics, self rescue/swimming techniques, ropes and knots, rescue equipment, rescue board techniques, as well as, hands on in the water practice. It is recommended that students be experienced swimmers in good physical condition. This class is taught on a Regional basis.

Pre-requisite: First Responder or Equivalent Course Hours:24/Min Enrollment: 20 Max: 40

NOTE; The student will provide their own personal flotation device (Swift Water type V), dive/rescue hard sheath knife, swift water rescue helmet, water rescue gloves, diving booties (hard sole), water type whistle (no internal ball), throw bag, and sturdy footwear for shore work; (3 mm wet suit required) 1 throw bag.

#### SWIFT WATER RESCUE II

<u>Course Description</u>: The Swift Water Rescue II course builds on the techniques learned in the basic class. This class is primarily hands-on in the water exercises. Heavy emphasis is placed on Swift Water boating operations and the rigging of rescue line systems for swift water applications. This class is taught on a regional basis.

Pre-Requisites: Swift Water Rescue I

Course Hrs: 20/Min- Enrollment: 20 - Max 30

NOTE: The student will provide their own personal floatation device (Swift Water Type V), dive/rescue hard sheath knife, Swift Water rescue helmet, water rescue gloves, diving booties (hard sole), water type whistle (no internal ball), throw bag & 2 green chem. sticks., and sturdy footwear for shore work; 3mm wet suit

#### CONFINED SPACE RESCUE

Description and information Has not been provided.

#### **DIVE RESCUE I**

<u>Course Description</u>: The Dive Rescue I course is designed to introduce qualified Scuba divers with underwater SAR techniques. Subjects covered include dive team equipment, procedures, and communications. Search patterns, recovery of victims, vehicles, and evidence are also taught in a mix of classroom and field exercises. This class is taught on a regional basis.

Pre-Requisites: Advanced open water certification, YMCA SLAM or equal, current first aid and CPR training.

Course Hrs: 24, Min Enrollment - 10 Max: 20

NOTE: See equipment requirement below on the Dive II.

#### **DIVE RESCUE II**

<u>Course Description</u>: The Dive Rescue II course is designed to build upon the DR I techniques. With many units supporting local law enforcement efforts, this class covers important procedures that should be followed in searching, finding, and recovering evidence in the underwater environment.

Pre-Requisites: Dive Rescue I

Course Hrs: 24, Min Enrollment: 10 - Max: 20

NOTE:\*Required Individual Equipment: Participants are required to furnish the following equipment: mask, fins, snorkel, BC, regulator, octopus, gauges (depth, pressure, compass), two full tanks, weight belt w/weights, (Full) wet suit or dry suit, personal marker buoy, knife, dive light, dive watch, whistle, and P.F.D. Underwater cameras & standard cameras are helpful for evidence documentation.

#### **BIG RIG RESCUE**

<u>Course Description</u>: The Big Rig Rescue program is designed to impart knowledge and develop skills in extrication techniques needed for large trucks and big road rigs. Stabilization techniques, access points and typical cab construction are some of the subjects covered. This class is a mix of classroom and field exercises.

Pre-Requisites: Basic Extrication Course Hrs: 20, Min Enrollment: 20

NOTE: Participants will be required to furnish and wear full Protective gear for all field exercises. Extrication coveralls are accepted but most do not meet NFPA standards. Rescue Tools will be provided.

#### **SCHOOL BUS RESCUE**

<u>Course Description</u>: The School Bus Rescue program is designed to give students a well rounded education on bus construction and types of buses. Basic extrication procedures, intermediate procedures, and advanced rescue techniques are taught in a mix of field and classroom exercises.

Pre-Requisites: Basic Vehicle Extrication Course Hrs: 20 Min-Enrollment: 20

NOTE: Participants will be required to furnish and wear full protective gear for all field exercises. Rescue tools will be provided. Lodging and food are on your own.

# RURAL SEARCH & RESCUE TECHNICIAN LEVEL

<u>Course Description</u>: The Rural Search and Rescue Course Technician Level is designed to introduce the participant to the complex concepts of land based search and rescue operations conducted in the rural environment. This course is intended

for all Law Enforcement, EMS, Emergency Management, Fire and Rescue Personnel that conduct land based SAR Missions. In this course the participant will receive instruction on the importance of proper SAR management, lost subject behavior, subject finder/locators, defining the role of the search manager and search personnel, introduction to map and compass reading, basic land navigation, and team building. The student will also receive introduction on basic rescue techniques such as; basic rescue knots and rope utilization for low angle rescue, and basic patient packaging for wilderness extraction. In this course the student will receive the awareness and operations level. This course is a mixture of classroom and field exercises.

Pre-requisites: NIMS IS100,IS200, IS700, TARS RSAR Level Training Program

Course Hours: 20 CEU's: 1.0 Min Enrollment: 10 Max Enrollment: 25

NOTE: This program consists of classroom and field training. The student will need to come prepared with pencil/pen and paper. The student may dress casual for the classroom portion, but must come prepared for weather appropriate conditions for the field training.

NOTE: See Rural S&R Operations Level for Equipment.

# **RURAL SEARCH & RESCUE OPERATIONS LEVEL**

The Rural Search and Rescue Course Course Description: Operations Level is designed to introduce the participant to the complex concepts of land based search and rescue operations conducted in the rural environment. This course is intended for all Law Enforcement, EMS, Emergency Management, Fire and Rescue Personnel that conduct land based SAR Missions. In this course the participant will receive instruction on the importance of proper SAR management, lost subject behavior, subject finder/locators, defining the role of the search manager and search personnel, introduction to map and compass reading, basic land navigation, and team building. The student will also receive introduction on basic rescue techniques such as; basic rescue knots and rope utilization for low angle rescue, and basic patient packaging for wilderness extraction. In this course the student will receive the awareness and operations level. This course is a mixture of classroom and field exercises.

Pre-requisites: NIMS IS100, IS200, IS700
Min Enrollment: 10 Max Enrollment: 25

# GROUNDBREAKING AT TENNESSEE FALLEN FIREFIGHTERS MEMORIAL

Groundbreaking ceremonies were held Monday afternoon for the Tennessee Fallen Firefighter Memorial on the grounds of Clarence "Pete" Phillips Fire Service and Codes Enforcement Academy on Unionville-Deason Road.

"Regional firefighters will attend this campus and visit this spot and know exactly, without misrepresentation, what they are aspiring to become and what the risks are," said Collierville Fire Chief Jerry Crawford, president of Tennessee Fire Chiefs Association.

Among the dignitaries participating in Monday's ceremony were Commissioner Leslie A. Newman of Tennessee Department of Commerce and Insurance, who serves as the state fire marshal; State Sen. Jim Tracy; and State Rep. Curt Cobb.

The site for the memorial was dedicated in October 2005. Since that time, firefighters statewide have been raising money, in part by selling memorial pavers. The original fund-raising goal for Phase I of the project — a plaza featuring the sponsor bricks and the names of fallen firefighters — was \$225,000, but in-kind assistance reduced the actual cost to \$180,000, which has now been raised, part of it by brick sales and part by corporate donations. Tennessee Fallen Firefighter Memorial committee president Ed Kay, Chief of the Sparta Fire Department, said organizers hope to have that phase ready for dedication by

Sept. 11 of this year.

Kay, who presided over Monday's ceremony, said Phase II of the project will include statues. Several speakers at Monday's ceremony said fundraising will continue, both for Phase II and for maintenance of the memorial once it is opened.

"I just want to say this means a lot to our family," said Marilyn Satterfield, widow of Nashville firefighter Paul Satterfield, who died while on duty in 1998. Mrs. Satterfield and her son Evan, who is also a firefighter, had been present for the dedication ceremonies in 2005, and attended the groundbreaking as well.

Crawford said that he had worked with 15 of the 78 fallen firefighters who will be memorialized. He referenced a Bible passage, John 15:13: "Greater love has no man than this, that he lay down his life for his friends."

Retired Shelbyville Fire Chief Garland King, who was one of the prime movers in encouraging the state to build the fire academy, expressed pleasure at the progress toward construction of the memorial. Retired firefighter Charles Vance delivered the invocation and the colors were posted by the Columbia Fire Department Honor Guard. Fire and Codes Academy executive director Roger Hawks welcomed visitors to the event.

#### 2008 Year End Review:

In December 2008, the Tennessee Emergency Medical Service Board met in final session for the year. 2008 has been an exciting year with new changes in EMS Practice in our State. #### Policy Changes for Rule Making Hearings:

A new policy change for rule-making hearings was implemented in 2008 by the TN Department of Health. It is now standard policy to require that rule-making hearings be conducted in conjunction with each particular Health Care Board Meeting. This policy change requires that EMS rule making hearings take place on the days of scheduled EMS Board Meetings. In my opinion, this is a very positive change in policy. The rule-making hearings will now take place at predetermined times throughout the year versus being conducted between Board Meetings.

The TN EMS Board is a legislative body, and the Board Meetings fall under the Sunshine Law. Visit the TN EMS Division website to view the Sunshine notices. You can also find a complete listing of the 2009 Board Meetings on the website.

#### Proposed Changes for 2009:

In Volume 14 of the *Rescue Line*, I reported on changes in the EMS Law which affect ambulance colors and markings.

The changes came about through State Legislation. In

2008, the EMS Board Chairman, Robert Byrd, appointed an Ad Hoc Committee to study current ambulance requirements and specifications.

The committee made recommendations to the Board with proposed changes in the EMS Rules and Regulations involving ambulance markings. The proposed changes were passed by the Board to the rule making process. The EMS Division anticipates that this issue will be presented for rule making during the March 2009 EMS Board Meeting.

New Air Ambulance Standards were also proposed in 2008. The Air Ambulance Standards Sub-Committee has worked tirelessly over the past several years to propose new regulations which will update the Air Ambulance Standards in the TN EMS Rules and Regulations. The proposed changes were passed by the Board to rule-making at the September 2008 Board Meeting. The Division anticipates that this issue will also be presented for rule-making at the March 2009 EMS Board Meeting.

#### Fees for some classes changing in 2009

Certain adjustments to some class fees have been made for this year. Fees have remained unchanged for a number of years and costs have continued to rise making necessary these increases. On college level programs you will note there is a difference in the swift water rescue fees versus other college level programs. Internal course costs have dictated this to keep the program solvent.

Level I Instructor fees are being adjusted to \$15 per year with the fee to continue to be collected biannually when an instructor updates. Squad level class fees will be adjusted around the 1st of April and will reflect the following adjustments. Basic Extrication & Full EVOC/VKF both will cost \$12 and include the certificate & wallet card. Extrication-Recert will increase to \$9.50 and include the wallet card only being issued. Extrication series certifications remain a 2 year suggested time period to recertify. The EVOC/VKF as a full program including the driver competency component is suggested as an initial baseline for departments and should be conducted at least every 4 years or sooner as determined by local standards. The EVOC/VKF-Recert, being the 3 hr classroom only program, may be used to meet the required State statutory requirement for annual driver training and will cost \$5 for wallet card documentation and has a 1 year certification period allowed.

The certified roster option will remain for the VKF program for agencies who do not desire individual documentation or CEU's at a minimum annual cost of \$50 (up to 25 people) & \$2 per person thereafter.

The Blood Borne Pathogen program will remain as an available rider to include on either program series which issues a card or combination certificate/card class documents when taught in conjunction with those classes at no additional charge. This option is not available on the certified roster selection for VKF. If taught as a stand alone program, and a certificate is issued for the BBP class, the charge will be \$12. These are the first price adjustments in 5-7 years and still represent a value unmatched when compared to similar programs which can cost many times the registration and documentation fees.

**Harassment & Discrimination Prevention Training** 

All instructors in the TARS system are being required to complete a program regarding prevention of harassment & discrimination in emergency service organizations. This training will be conducted at each of the regional instructor updates in April of 2009 and 2010. College level instructors will complete the training in their updates as well. Further reinforcement of association policies in regards to no alcoholic beverages being endorsed in connection with functions, and the importance of HIPPA regulations will be addressed as well.

#### Website Changes and Updates

The website has become a valuable tool for communicating information over the past decade. Many changes and new resources continue to provide a faster more efficient way for the association to conduct its business. With such technology come many challenges as well. This past year, multiple attacks by computer hackers created havoc with our forum, website access, and class roster/documentation system. Despite increased security measures being implemented, a second successful penetration required a major revamping of the programming and security features that resulted in over a month the online system was required to be under repair. We are currently testing for any flaws and making corrections as needed in order of priority and hope to have the systems back up in the next week or so. Certain changes will require your cooperation in the new system, such as strong password protection and additional steps before access is granted in secure areas. We are making progress on the testing of a new membership & squad database area which will make updating of resources, membership, and certain features that will benefit TARS full unit's ability to keep up with administrative records a reality. This testing will begin this year and hopefully will launch sometime by 2010 for operation.
